MINUTES OF MARCH 13, 2015 MEETING

Tom T opened the meeting and distributed the Minutes of the March 13, 2015 Alano Club Business Meeting.

Jim L moved **THAT**:

MOTION: The Minutes of the March 13, 2015 Business Meeting be adopted as read.

WEBSITE

Kim R reported that from mid-March until April 17th the Alano Club Website received 289 visits, 243 users and 554 pages that were viewed.

CONSTITUTION

Jim L reported that Murray H now has a copy of Constitution for his review. Both Jim L and Murray H will be meeting with Doug C to discuss the Constitution in May. Any change in the Constitution requires Victoria's approval – 75% approval for the Constitution and 50% approval for the Bylaws.

FINANCIAL REPORT

Tom T distributed copies of the Financial Report. For the first time The Alano Club operated in the black. A \$5,000.00 GIC is due on April 20th. The Club is purchasing more food and spending approximately \$200.00 per month in cream. Due to the positive response, the Cafeteria's menu has been expanded to include Smokies and Veggie Burgers.

BOARD OF DIRECTORS' MEETINGS

A discussion took place regarding establishing a convenient time for all of the Board of Directors to meet. It was agreed that the Board of Directors' Meetings will now take place at 6:30 p.m. on Friday night. This will enable all Board Members to attend the meeting.

MEMBERSHIP

To date the Alano Club has 89 Members with 4 Members owing. Tom T has completed a Reference Guide as to how New Members are processed from entering their names in the Receipt Book to the Members names being placed on the Membership Board. This includes entering the dues in the Cash Register, Receipt Book, Membership Page, Email Database and finally the Membership Board. Kim R reported that only two Directors have access to the Drop Box which contains the complete list, himself and Tom T.

FLOORING

Tom T received an estimate for the replacement of the carpeting at the Alano Club. Online, the carpet retails for \$19.00 per square foot. The cost of the carpet is approximately \$6,289.00 which does not include the purchase of glue, edging and supplies. The total cost of the carpeting, supplies, edging and installation will be approximately \$9,500.00.

installation of the new carpet.

CAFETERIA NAME

Jim L chaired this Agenda item. A lengthy discussion took place with respect to the naming of the Cafeteria.

MOTION: The Café to be named the "Rock Bottom Café".

Seconded by Tim C.

The Motion was discussed and defeated.

It was decided that the naming of the Cafeteria would be deferred to a later date with a suggestion made of holding a Naming Contest. Details of the contest will be announced at the AGM and that the contest winner would be announced at the Grand Re-Opening of the Alano Club.

The question of whether or not the kitchen in the Cafeteria should remain open for a limited amount of time was discussed. At this time, because of the lack of volunteers and interest the decision will be postponed until there is further discussion.
